The Office of the State Treasurer of Ohio (“Treasurer’s office”) is soliciting information from Managed Care Organizations (“MCOs”) that have received statewide certification from the Ohio Bureau of Workers’ Compensation (“BWC”) concerning the BWC’s 2014 MCO open enrollment.

The Treasurer’s office employs approximately 120 individuals.

The Treasurer’s office would like information from BWC statewide certified MCOs on the following items, at a minimum:

- First Report of Injury (FROI) timing;
- FROI turnaround;
- Return to work statistics; and
- Claim cost statistics.

Interested firms should respond to this Request for Information (“RFI”) in all applicable respects. Responses to this RFI are strictly limited to a total of ten (10) pages. Responses to the RFI are also required to submit a complete electronic copy of the response in MSWord or PDF format, either via email or on CD.

It is the policy of the Treasurer’s office to accept questions and inquiries from all respondents. Respondents may submit questions about the intent or content of this RFI, and request clarification of any and all procedures used for this selection prior to the submission of responses. Any inquiries shall be sent via e-mail to Meredith Rockwell, General Counsel, at [meredith.rockwell@tos.ohio.gov](mailto:meredith.rockwell@tos.ohio.gov). The deadline for receipt of all inquiries is **5:00pm Eastern Daylight Time on Tuesday, May 13, 2014**. Responses to questions about the RFI will be posted within two (2) Business Days of the question being received via email. The responses will be posted on the Treasurer’s office’s website at [www.ohiotreasurer.gov/forms](http://www.ohiotreasurer.gov/forms). Please note that all questions and answers become a matter of public record and may be made available to all RFI respondents. Responses that are labeled “confidential,” or contain information identified as “confidential,” will not be considered by the Treasurer’s office.

The Treasurer’s office may conduct interviews with one or more respondents. The Treasurer’s office may take into consideration any other information, including information not requested in this RFI or not included in the statements received.

This RFI is not and shall not be construed as an offer of a contract by the Treasurer’s office. Any selection for MCO services will be evidenced through the appropriate process required by the Ohio Bureau of Workers’ Compensation and/or the Ohio Department of Administrative Services.
